Key figures of the Official Development assistance (ODA) published by the OECD today

A course set by the French President and the Government: 0.55% of GNI in 2022

Many upcoming events, especially in France: **Orientation and Programming Law**, G7, replenishment of the Green Climate Fund and the Global Fund to Fight AIDS, Africa-France summit, etc.

## **O** PLANET: 100% PARIS AGREEMENT

**€1.6 billion in 2018 for climate change adaptation projects** (x2 compared to 2017)

**"Transforming Financial Systems for Climate" project** \$750 million including \$280 million from the Green Climate Fund: the biggest program in AFD Group history

Two tools to support the most vulnerable countries: Adapt'Action to implement national contributions and the 2050 Facility to support long-term strategies.

## **O** POPULATIONS: 100% SOCIAL LINK

**\$345 million\* delegation of funds from the Global Partnership for Education** for projects in Burkina Faso, Burundi, Niger, Guinea and Senegal

**Gender-responsive budgeting (GRB)** via a public policy loan to Morocco

€497 million dedicated to health projects in 2018

Sahel Media Project: Reinforcing the capacity of independent media in the Sahel region (in Burkina Faso, Mali & Niger)

**Sport for development:** projects in Mayotte, Morocco, South Africa & Palestine and a partnership with the NBA

**Defence, Diplomacy & Development: three areas of proficiency that are being enhanced** and enabling France to roll out all its expertise and provide a collective, long-term response.

Over €2 billion for the Sahel since 2013: a sharp increase in our resources to respond to emergency needs and vulnerabilities with a quick execution ability.

Projects targeting **the most vulnerable areas**: vocational integration of young people in Gao, healthcare in Ménaka, water supply in Mopti, etc.

Enhanced coordination with 12 other donors within the **Sahel Alliance** in partnership with the G5 Sahel: a total of 680 projects for €9 billion

### O PROSPERITY: PRIORITY TO NON-SOVEREIGN PROJECTS



The **French initiative** implemented by Proparco to boost entrepreneurship and innovation in Africa.

**€2.5 billion and 10,000 companies** supported between now and 2022

All the AFD Group's tools are put to use for start-ups and SMEs



**IDFC Club of 24 development banks:** their alignment with the Paris Agreement is acknowledged.


**STOA**, the investment vehicle in association with Caisse des **Dépôts**, continues its contributions to essential sectors: wind turbine platform in India, hydroelectric dam in Cameroon, etc.

**Digital Africa**: a multi-player platform to support the entrepreneurial eco-system in Africa.

With the EU, Australia & New Zealand: the **Pacific Initiative** on biodiversity, climate change and resilience intended for small island states.



The importance of governance: €1.4 billion in commitments (+21% in one year), including 41% in institutional and citizen governance


## **O** AFD, A HIGH-PERFORMANCE MODEL




## **O** AFD Group: A WORLDWIDE NETWORK



### **O** 4 KEY AREAS OF INTERVENTION




## **O** AFRICA: ACROSS THE CONTINENT

## **EVALUATION** LEARNING FOR PROGRESS

TOWARDS A WORLD IN COMMON

## **O** THE PERFORMANCE CHALLENGE

The AFD evaluation programme is being structured and enhanced.

Learning: learning lessons to improve the efficiency of actions and their impacts on the quality of life for populations.

Accountability: evaluation enables us to take better stock of our actions.

### 44 project assessments conducted in 2017-2018 for 68 projects



### EXAMPLE: SCIENTIFIC IMPACT ASSESSMENT FOR A WATER SUPPLY PROJECT - UVIRA, DRC

### The project

To improve drinking water production and distribution facilities for 155,000 people in areas affected by cholera epidemics.

The scientific impact assessment measures the direct effects on cholera and diarrhoeal diseases attributable to improved water supply.

#### **Initial results**

- 23.2% of cholera cases reported in the town for the period 2009-2014 were directly attributable to recurring breakdowns in the drinking water treatment plant.
- "Only" 40% of suspected cases are genuinely due to cholera infection.

#### Conclusions

-Proves the effectiveness of long-term investments in infrastructures compared to emergency intervention (vaccination, distribution of chlorine tablets, etc.) in the fight against cholera.

-Fosters international dialogue (Water SDG)



**Double the number** of projects evaluated between now and 2020 (33 in 2018, 45 in 2019 and 65 in 2020) and **the budget allocated to assessments** ( $\leq 1.5$  million to  $\leq 3$  million)

**More joint assessments** with the Ministry for Europe and Foreign Affairs, the Treasury, the EU and our counterparts (KfW, IEB, etc.)

**Increased involvement** of our partners and beneficiaries in evaluations

#### Improved transparency

- Systematic publication of results (72 at present, 100 by end 2019)
- A public report every two years
