FD Group's work on governance promotes the development of fair and united societies that respect the freedoms and rights of all human beings. The Group finances institutional-, political-, and citizen-focused initiatives with a view to strengthening trust between people, States, and institutions, and fostering sustainable development. To this end, AFD Group supports actors driving innovation, reforms, and transformations for their countries and regions, organizations, and citizens

While governance falls mainly under the Sustainable Development Goals (SDGs) 16 and 17, it also supports several other SDGs (5, 10, 11, 12, 13).

AFD Group's portfolio of governance-related operations touches on a wide variety of themes that encompass the full spectrum of the social contract. The scope of governance covers activities to strengthen the rule of law and public action, open up the civic space, manage migration, support sustainable development policy financing, and contribute to macroeconomic stabilization.

Rising numbers of crises and conflicts, the effects of climate change, democratic backsliding, and the impacts of all of these on mobility make migration challenges all the more significant for socioeconomic development and political dialogue in our partner countries. The importance of these issues is echoed today in AFD Group's operations, as shown by the substantial increase in the number of projects and investments dealing with governance.

In 2024, AFD committed €522 million in grants and loans for governance-related issues, for a cumulative volume of €8.2 billion since 2016⁻¹

AFD Group's governance strate

AFD Group aims to make governance a tool with which to transform societies, consolidate public action, and accelerate transitions, at a time when the world is greatly affected by climate and environmental crises, democratic backsliding, persistent inequality, and risks associated with digital technologies.



Our governance activities center on four main priorities:



CONTRIBUTE TO MORE OPEN AND UNITED SOCIETIES

Promote democratic vitality, public transparency and accountability. the accessibility and safeguarding of civic spaces, and the right to reliable information – these are the foundations of inclusive public policies that reduce inequality and ensure respect for human rights.



STRENGTHEN THE RULE OF LAW AND PUBLIC ACTION

Support the transformation of public administrations and the provision of public services at all levels of the country or territory, ensure access to justice and rights, and reduce and manage disaster risks.



SUPPORT SUSTAINABLE DEVELOPMENT FINANCING

Make public financing a tool for transitions and sustainable development, and direct resources and investments, including those from diasporas.



REINFORCE MACROECONOMIC STABILIZATION **AND CRISIS RESPONSE**

Provide financing, upon request of the French government, to address economic, social, environmental, and security crises.

AFD Group's approach

By bringing Expertise France under its umbrella in early 2022, AFD Group now has a set of complementary tools to support all its partners. One of Expertise France's main tools is French and European expertise, backed by AFD financing, to assist with the development and implementation of sustainable public policies.





In 2024, AFD was able to leverage its entire set of financial tools, in particular sovereign loans. Nearly half of these sovereign loans took the form of budget financing, which supports in-depth dialogue on public policies.



Evolution in commitments





Contributing to more open and united societies

Our ambition is to contribute to the development of fair, united societies that respect people's freedoms. To this end, AFD promotes the establishment of continuous dialogue between public authorities and citizens, transparent public action, open civic spaces, and the right to reliable information. It supports a social contract that protects individual freedoms, bolsters peace-building, and promotes safe, orderly, and regular migration that ensures respect for migrants' rights. Its activities help reduce multidimensional inequality (including gender disparities), address the causes of vulnerability related to forced migration, and foster peaceful coexistence. Given the growing importance of migration issues around the world, AFD Group has developed a specific action plan* on the topic of migration.

Promoting women's participation in community-based crisis prevention and response.

The Women Lead in Emergencies project seeks to increase women's participation and leadership in conflict prevention, peace-building, and climate change resilience, in line with the Women, Peace, and Security Agenda. Four women's rights organizations will be supported to see through their peace-building, human security, and climate change resilience initiatives. At the community level, 78 women's groups will receive capacity-building on crisis prevention, personal safety, and increased civic engagement.

Strengthening the rule of law and public action

Our objective is to support effective, transparent, and accountable public action that serves the common good. To this end, AFD provides assistance to transform public administrations into competent, efficient, and responsible institutions that are able to ensure freedoms and rights are respected, implement public policies, and provide access to public services.

AFD's work focuses on central and devolved administrations as well as on local authorities and public services. It also supports inspection bodies (Court of Auditors, general and sectoral inspectorates) with the aim of addressing all of the public's needs through fair, quality services.

Jordan



Modernizing the public sector

Jordan is working to create a more modern, transparent, and accountable public sector. Through a budget support loan, AFD is supporting the implementation of this ambitious reform program, which is especially focused on public services (digitalization and accessibility), planning aspects, public HR management, and increasing women's representation in the public sector. This loan will enable the launch of an online participation platform to gather the opinions of Jordanians about the reforms under way. The Ministry for Education will also receive support for its internal restructuring activities and efforts to modernize its HR management.

Sustainable development financing

Our goal is to help States harness and allocate their resources in the best way to achieve fair and sustainable transitions. As the leading development investors, States act as catalysts in directing private sector activities toward more sustainable investments. Like diaspora investments, public financing is a major tool to fund transitions and help align the goals of promoting fair and united societies and tackling climate change. AFD's support is designed to enable states and local authorities to tap into, plan, mobilize, and manage their financial resources in order to meet long-term goals and achieve stronger fiscal sovereignty.

AFD Group expanded its commitments to support migration governance, mobilizing €730 M in AFD and EU funds between 2017 and 2024, including €130 M in 2024. Investments to prevent irregular migration, migrant smuggling and human trafficking, and assist with return efforts increased tenfold over 2023.

AFD Group's "Migration and Development" action plan lays out the Group's new strategy, in full alignment with the Joint Valletta Action Plan. 4 This action plan is built around three key objectives:

- Emphasize the benefits of migration for development
- Promote safe, orderly, and regular migration that ensures respect for migrants' human rights
- Reduce the vulnerabilities related to forced migration

Macroeconomic stabilization

At the request of the French government, AFD provides financing in response to major shocks (economic crises, droughts, conflicts, etc.). This financing, which is generally provided jointly with other donors, must be able to quickly provide the liquidity injections needed to stabilize a crisis situation

Ethiopia

Supporting the economic reform program



With an annual growth rate of 10.8%, double the average of the rest of Sub-Saharan Africa, Ethiopia was experiencing strong economic growth until 2020. Growth has since slowed in the country, mainly due to the effects of the COVID pandemic, climate change, and internal conflict. To address the situation, the Ethiopian government announced its "Homegrown Economic Reform Agenda", which France has committed to supporting. This budgetary aid, combined with technical assistance, will be used to develop publicprivate partnerships, implement reforms in public companies, and support structural changes to the financial system.

Expertise France's governance activity

Expertise France is the AFD Group entity responsible for implementing technical cooperation projects that fall under the broad scope of governance: public financial management, migration, gender, human rights, justice, government reform and local governance, and disaster risk reduction



Over **800** organizations received capacity-building support in 2024 in democratic, economic, and financial governance, including 106 local authorities.

To carry out its work, Expertise France relies mainly on the French public ecosystem, which includes the central government (Public Finances Directorate General, Directorate General for Digital Affairs, Interministerial Directorate of Public Transformation, Ministry of Justice, Directorate General of Administration and Civil Service, Security and Defense Cooperation Directorate, etc.); inspection bodies (Court of Auditors, General Inspectorate of Finance, etc.); specialized schools (National School for the Judiciary, National Institute of Public Service); the National Assembly and the Senate; and French local authorities.
