OUR ACTIONS IN THE WATER SECTOR IN **Lebanon**

In Lebanon, despite the availability of water resources and significant investments made, the population still does not benefit from a reliable and continuous water service. Since 2019, the profound socio-economic difficulties the country has been experiencing have accentuated the fragilities of a public water and sanitation service, threatening its continuity and sustainability. This sector is characterized by a vicious cycle of insufficient service and financial imbalance, within a governance framework poorly suited to modern and efficient management of resources and infrastructure. Added to these structural difficulties are external factors such as the Syrian crisis and climate change, as well as issues of informal and illegal competition.

In response to these issues and challenges, France, through the Agence française de développement (AFD), is actively engaged in Lebanon to support and strengthen the water sector according to an overall strategic vision, which aims to ensure service continuity, its financial viability and the improvement of its governance.



Improving Service for Users Throughout the Lebanese Territory

Increasing the geographical coverage of public water services and improving their reliability constitute one of AFD's intervention priorities in Lebanon. Projects thus aim to complete unfinished drinking water systems across the entire chain and to rehabilitate facilities and equipment, having a direct impact on the quality of service provided to users.

In partnership with the European Union, UNICEF, ICRC and the NGO WW-GVC, the **Enhanced Drinking Water Service in Lebanon (SEPAL) project** enabled **37 localities across the country** to benefit from a tangible improvement in drinking water service, even during the socioeconomic and security crisis. Interventions focused on **modernizing pumping stations, replacing pumps, installing solar systems** and **extending transmission and distribution networks**.

Results:

+5 hours of water per day on average for users



-40% energy costs for operators

TTI Trust restored between users and public service

These results have laid the foundations for a **new economic balance of the service**. This approach, focused on service rather than large infrastructure, has demonstrated its effectiveness and resilience in the face of successive crises in Lebanon.

It now inspires the **Performance Improvement, Access to Infrastructure and Water Services (APAISE) project**, conducted with the Beirut and Mount Lebanon Water Establishment, which continues this momentum to strengthen performance, access and service quality.



Strengthening Water Sector Governance

AFD works, in close partnership with the Ministry of Energy and Water and the Regional Water Establishments, to strengthen governance and modernize the sector's institutional framework.

A **structural reform support program**, funded by the European Union and implemented by AFD, supports the **sector's recovery** by improving its organizational framework, resilience and capacity to provide quality water and sanitation services.

Interventions focus notably on strengthening the organizational and regulatory framework, supporting digital transformation and developing public policy.

In parallel, AFD plays a driving role in sector coordination and dialogue on public policies related to water and sanitation. The EU-AFD technical assistance program for sector reform, conducted in collaboration with local actors and donors, helps orient policies and programs toward sustainable solutions meeting the priority needs of the Lebanese population.
