Support for civil society organizations

2024

The year 2024 marked the 15th anniversary of the CSO Initiatives Fund, a key moment to review the progress made, highlight the relations developed with CSOs, and reaffirm their pivotal role in the achievement of the Sustainable Development Goals (SDGs). Behind the numbers, the anniversary is marked by 15 years of sustained commitments, ever-increasing confidence, and a common vision of international solidarity. Despite a tight budgetary situation, AFD Group continued to maintain a high level of commitments in support of CSOs, with nearly €520.7 million in grants, including €153.5 million via the CSO Initiatives Fund. Expertise France, the Fund for Innovation in Development (FID) and the French Facility for Global Environment (FFEM) committed €114.5 million, including delegated funds. Our sectoral divisions and the Crises and Conflicts Division mobilized €148 million and €89 million, respectively. This high level of commitments underscores the specific place of civil society within AFD Group's action.

Through its partnerships with civil society organizations (CSOs), AFD Group has continued its work in the field and its engagement on issues related to gender inequality, migration, climate transition, and the promotion of human rights-based approaches. In an increasingly unstable and fragmented environment – marked by multiple climate, political, and social crises – it is essential to maintain strong ties with civil society actors.

The year was also marked by strong engagement in support of young people: nearly 100 out of 132 projects funded under the I-OSC mechanism were partially or fully targeted toward youth – a key focus of AFD Group's 100% "Social Link" strategy.

Lastly, 2024 was marked by significant international instability, growing challenges to official development assistance, a shrinking civic space in many countries, and a deepening polarization of views on international solidarity. These developments are threatening the stability of the sector and of civil society organizations (CSOs), and call for an even stronger strategic partnership. They also require us to rethink and renew our ways of working and our alliances in order to face these challenges. Being able to build on 15 years of close cooperation and mutual understanding between AFD Group and its partners is a valuable foundation for this reflection.



Across all mechanisms (in €M)




Geographical breakdown



CSO Initiatives Fund

A financing mechanism for French and locally registered CSOs since 2009

With the CSO Initiatives Fund, CSOs can submit a project amounting to €500,000 or above, on their own initiative, to request co-financing from AFD (up to 80% for French CSOs and 90% for local CSOs). It thereby contributes to strengthening civil societies and their action all over the world, especially in the least developed countries (LDCs), in conjunction with local organizations.







Gender and women's rights: Support Fund for Feminist Organizations (FSOF)

48 projects financed by AFD for €49 M in 2024

The Support Fund for Feminist Organizations has been jointly managed with the French Ministry for Europe and Foreign Affairs (MEAE) since 2020 and embodies France's commitment to feminist diplomacy. This fund supports CSOs working for women's rights and gender equality.

€ Project amount: €555,000 - AFD grant: €500,000

This project aims to provide assistance to survivors of sexual and gender-based violence in Conakry by supporting the operation, implementation of activities, and long-term sustainability of the Center for Survivors of Sexual Violence committed during the September 28, 2009 stadium massacre.



Governance and human rights 🇪

Together Against the Death Penalty (ECPM) in Africa, Asia and the Middle East

€ Project amount: €3.38 million 🇪

AFD grant: €1.45 million

Led by **ECPM**, this project contributes actively to the fight for the universal abolition of the death penalty in 11 countries in Africa, Asia and the Middle East. It is strengthening expertise, synergies and the capacity for dialogue between national authorities, civil society and criminal justice stakeholders, with the aim of driving positive political and societal change. This project is reinforcing national and international advocacy with institutions in order to move forward the debate within civil society and the media. It also focuses on young people, with specific action targeting 120 young people in support of abolition. Through this work, it is strengthening transparency and support for the legal representation of convicted persons. Ultimately, the initiative also strengthens transparency and support for the legal representation of those convicted.

Projects for Education for Citizenship and International Solidarity (ECIS) and structuring the non-profit sector (SMA) in 2024: 12% of funded projects

Projects for ECIS and SMA aim to reinforce the network of French associations and mobilize citizens around international issues.

Editorial cartooning in support of the Sustainable Development Goals

Project amount: €615,809
AFD grant: €296,000

Given the interlinkages between the realization of human rights and the achievement of the Sustainable Development Goals, the association **Cartooning for Peace** mobilizes its network of cartoonists to raise awareness among young people and adults of the interlinkages between human rights and sustainable development. It develops educational resources and organizes exhibitions, training and debates to promote civic engagement for human rights and the SDGs.

Supporting the structuring and empowerment of diaspora organizations and their networks

Project amount: €1.6 million
AFD grant: €1.2 million

This project aims to connect migration stakeholders both here and abroad. Through capacity-building initiatives for organizations, **FORIM**, known as the principal representative of diaspora and migrant associations, seeks to strengthen international solidarity efforts led by migrant organizations. These efforts are part of long-term strategic alliances that can amplify their contributions toward the Sustainable Development Goals.

Thematic breakdown



Critical Ecosystem Partnership Fund (CEPF)

Created in 2000, **CEPF** aims to preserve the ecological integrity of 36 biodiversity hotspots that are among the most threatened in the world. It provides funding and long-term capacity building for local populations, organized as CSOs, while aligning with national priorities.

According to its 2023 annual report, CEPF supported 2,735 CSOs in 112 countries (in 25 of the 36 hotspots), contributing to improved conservation of more than 55 million hectares and the protection of 17.1 million hectares within these hotspots.

In 2024, €26.5 million was allocated through an EU delegated fund (€21.5 million) and an AFD grant (€5 million) to support conservation efforts in four priority hotspots – Indo-Burma, Eastern Melanesia, the Brazilian Cerrado and the Mountains of Central Asia – and to establish a CEPF emergency response mechanism for interventions following natural disasters.

The Minka Instrument

W Civil Society Innovation Fund 2 Program in Ethiopia

€ Amount of the project and Minka grant: €4.5 million

This flagship initiative to protect and expand civic space in Ethiopia plays a key role in supporting local civil society organizations (CSOs) and advancing aid localization. One of its components involves providing technical and financial support to 23 emerging Ethiopian CSOs, grouped into six consortia, to strengthen their work on peacebuilding, democratic dialogue, and the promotion of fundamental rights.

Expertise France

W PRIM: Regional Program for Migration Initiatives in Morocco

€ Project amount: €3 million Expertise France grant: €2 million


Led by the Migration and Development program (AFD financing – €9 million), the PRIM project is contributing to the implementation of Morocco's migration policy at regional level. The activities are mainly implemented by CSOs, in conjunction with local authorities and diaspora associations, third-country nationals, and local associations. The objective is to promote migration as a factor of development in areas in the Souss-Massa and Oriental regions. It provides funding for concrete initiatives, most of which are led by civil society organizations working on migration and development. These initiatives are aligned with regional, provincial and municipal development plans related to migration. To this end, local stakeholders (including decentralized state services and public agencies) are involved in project selection, drawing on their in-depth knowledge of local needs and realities.

French Facility for Global Environment (FFEM)

Six large-scale projects have been implemented for international, French and local CSOs on issues including biodiversity, the sustainable management of agricultural and forest land, climate change, etc.

₩ Côte d'Ivoire - Creation of a "Zero Deforestation" sector

€ Project amount: €3 million – FFEM grant: €1.5 million

The "Equité cacao" project, co-financed by the French Facility for Global Environment (FFEM) and AFD, is led by the CSO Commerce Équitable France in partnership with Agronomes et Vétérinaires Sans Frontières. It aims to develop a zero-deforestation cocoa supply chain that benefits small-scale producers in Côte d'Ivoire, Ghana and Togo. The project draws on fair trade networks to support the adoption of agroecological practices and help producers comply with new anti-deforestation regulations in the targeted areas.

Fund for Innovation in Development (FID)

₩ Madagascar - Improving learning outcomes by promoting menstrual hygiene

€ Amount of the project and FID grant: €1.5 million

In Madagascar, the NGO CARE is implementing the Kilonga program to improve menstrual hygiene. By combining health facilities, awareness-raising, training, and an innovative approach using "Young Girl Leaders" to tackle stigma, this project has had a positive impact on the academic success of girls. An evaluation is currently being conducted in 140 schools, and the authorities are showing interest in scaling it up.

Partnership and dialogue, an eventful and increasingly diverse outcome for the year

In coordination with the French Ministry of Foreign Affairs, AFD maintained a high level of dialogue and consultation with civil society organizations and foundations. Several events and dialogue platforms helped strengthen ties with partners.

February

“Champions of Education” seminars with the Education Coalition

Since their launch in 2018, the Education Champions initiative, co-organized by AFD and the Coalition Éducation, has aimed to promote cooperation and facilitate the exchange of practices and operational recommendations on education challenges in partner countries, with the goal of strengthening education policies and programs.

Conference on responsible tourism

AFD supports the NGO AFRAT in creating the first long-distance hiking trail network in the Middle East, promoting exchanges, research and knowledge sharing. The project aims to boost rural economic development through hiking tourism.

March

Conference on feminism in Tunis

AFD hosted the photo exhibition “Our Rights, Our Struggle, Our Future”, which explores the link between the Sustainable Development Goals and human rights. Over the past ten years, the AFD-FIDH partnership has supported 250 civil society organizations in 120 countries, promoting women's rights and fighting impunity affecting vulnerable populations.

Conference on diabetes

Organized by AFD Group, Santé Diabète and the World Diabetes Foundation (WDF), the conference provided an opportunity to reflect on how to integrate care for diabetes/HIV and diabetes/tuberculosis comorbidities in order to strengthen health systems and improve access to care.
