Green Agenda public-policy loan

2023 - 2025

2 ALBANIA

Water infrastructure modernization

2022 - 2026

Improving drinking water distribution (2022) and sanitation (2026) in Durrës by developing separate wastewater and rainwater networks for the city, aligned with European standards.

Energy public-policy loan

2023 - 2028

Supporting the country's energy sovereignty and security by supporting reforms for the energy transition, energy efficiency and renewable energies.

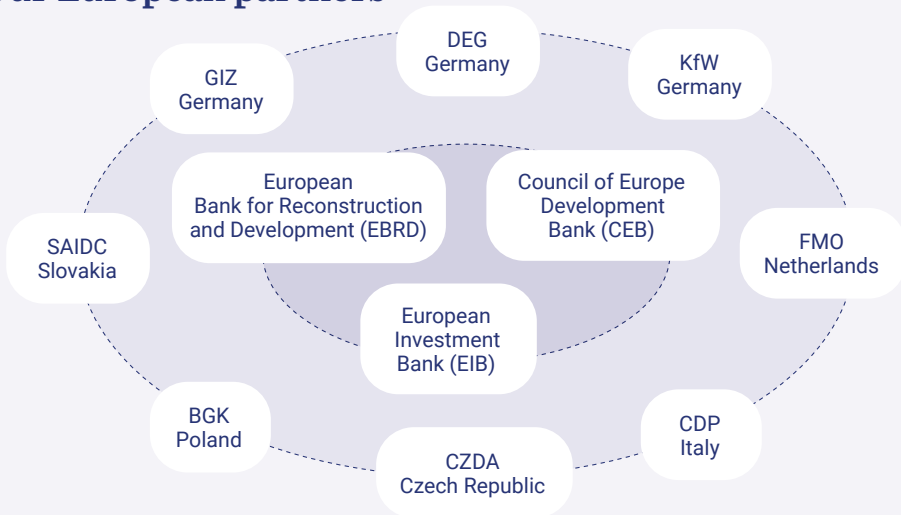
